

TRANSIT, PARKING AND TRAFFIC COMMITTEE MEETING MINUTES

FEBRUARY 27, 2015 1:00 PM

Approval of Last Meeting's Minutes: Jeremy McAtee made a motion to approve the minutes from January 22, 2015, after corrections. The motion was seconded by Mikey King. Motion carried unanimously.

Report on Current Status of Parking:

Gary gave the following parking updates:

- Lot 38A – The building has been demolished and are currently waiting on the fence removal. This lot will be designated as faculty/staff parking for approximately six months, then the Phi Mu's will begin building.
- Lot 44 - The City of Fayetteville will be adding a manhole on Razorback Road beginning Monday. This will be a two day project. After completion, a three-week sewer project will begin. There will be detours for entrance into Lot 44 from Razorback Road.
- There will be a high pressure gas line installation project beginning April 2015 (90-day project). The project will extend from Nettleship Street to the Central Plant on Dickson Street.
- Transportation study update: The consultants will be back on campus in March. More information will follow after that meeting. Some RSO's will be helping with the transit passenger counts.
- There will be maintenance performed in the Stadium Drive, Harmon, and Garland garages this summer.
- Lot 40A, a resident reserved lot, will be reconstructed this summer using a low impact design.
- Lot 75 will be constructed this summer using three levels due to the topography.
- We hope credit cards will be accepted in Luke meters by the time students return from spring break.
- There will be testing on single space meters and their ability to accept credit cards.
- The triennial review for Transit has been finalized with no major findings.

Old Business:

Lot 39 Redesignation:

Mikey King made a motion to redesignate Lot 39 as a faculty/staff parking lot effective July 1, 2015. Jeremy McAtee seconded this motion. Motion failed – those opposing were Mikey King, Samantha Fehr, Kristin DeAngelo, Andrew Braham, Matt Trantham, Nick Stauffer, and Felisha Perrodin.

Laura Shiver made a motion to redesignate Lot 39 as approximately one half student parking lot and approximately one half faculty/staff parking lot effective July 1, 2015. Tim Kring seconded the motion. Motion carried – opposing were Samantha Fehr and Kristin DeAngelo.

Kristin DeAngelo made a motion to designate Lot 39 as a no overnight parking lot effective July 1, 2015. Samantha Fehr seconded the motion. Motion carried – those opposing were Mikey King.

Scholarship parking for 6 pm weekday basketball games will be tabled until the August meeting.

Tim Kring made a motion to extend men's basketball scholarship parking to exhibition games beginning July 1, 2015. Matt Trantham seconded the motion. Motion carried unanimously.

Clearing Lots 55, 56D, 60 and 62 for women's basketball games will be tabled.

Jeremy McAtee made a motion to increase the citation fee for unauthorized parking in or blocking of a disabled persons parking space or access aisle from \$100 to \$150 effective July 1, 2015. Kristin DeAngela seconded the motion. Motion carried unanimously. The increase in fee will be used for ADA education.

Tim Kring made a motion to increase the citation fee for athletics prohibited by sign from \$55 to \$100 effective July 1, 2015. Mikey King seconded the motion. Motion carried unanimously.

Felisha Perrodin made a motion to limit annual parking permits to one per student since the permits are transferrable from one vehicle to another effective July 1, 2015. Tim Kring seconded the motion. Motion carried unanimously.

Tim Kring made a motion to create a citation and fee for running a gate at Harmon Garage with the citation fee being \$50 plus the cost of the daily parking rate in the garage effective July 1, 2015. Lisa Frye seconded the motion. Motion carried unanimously.

Felisha Perrodin made a motion to increase the citation fee for running a gate at Harmon Garage from \$50 plus daily rate to \$100 effective July 1, 2015. Tim Kring seconded the motion. Motion carried unanimously.

New Business:

- Lot 75 designation and athletic use of Lots 39 and 75 will be tabled and discussed at a later date.

- Scooter insurance: After discussion it was decided since the legislators are working on this issue, UA will await their findings. This should be a state issue, not a UA issue.

Jeremy McAtee made a motion to adjourn the meeting. Matt Trantham seconded the motion. Motion carried. The meeting was adjourned at 2:50pm.
